## **UNIVERSITY RULES FOR RE-MID EXAMINATION**

1. A student may request for the Re-Mid Examinations, if for some genuine reasons (beyond his control), he fails to appear in a mid-semester examination.
2. For the request of Re-Mid, the student will apply on a prescribed Form "**Re-Mid Exam Form**" to the Chairman/ HoD of the concerned department, who will refer the case to the Departmental Semester Committee for consideration. The Departmental Semester Committee will make its recommendations based on the genuineness of the case.
3. In case the student is allowed for Re-Mid in a course by the Chairman/HoD of the Department on the recommendations of the Departmental Semester Committee, he would be allowed to take only Mid Semester Examination of that course on payment of prescribed fee.
4. The Re-Mid must be held before the starting of End Semester Examination, failing which will automatically be converted to zero Marks.
5. Fee for Re-Mid Examination is Rs. 1000/- per course.
6. In case of repetition/improvement of a course during regular semester, no request for Re-Mid exams or 'I' grade will be entertained.
